#### 1. Introduction

The Ethiopian Civil Service University (the then Ethiopian Civil Service College) was established in 1995 by the Office of the Prime Minister to deliver the skilled human power needs of the country's public organizations. For this purpose, it offers undergraduate and postgraduate programs in various fields. The University reviewed its admission criteria and prepared this booklet to augment customer satisfaction. These criteria will be used for the recruitment of Masters' Degree for 2019/20 (20012 E.C.) candidates. The booklet introduces the Colleges, Programs and detail admission criteria for each of the Program.

# 1. COLLEGE OF URBAN DEVELOPMENT AND ENGINEERING (CUDE)

College of Urban Development and Engineering had been established in October 1970 by the name of: *I'Ecole Technique Superieure Des Municipalities* with agreement between France and the then Imperial Government of Ethiopia. The aim was to provide students with scientific knowledge which enable them to solve technical problems they encounter in the municipalities including Surveying, Hydraulics, Topography and Higher technicians in building and urban planning. It had been formally merged with the then Ethiopian Civil Service College in 1987/95.

The Graduates from the College of Urban Development and Engineering (CUDE) Programs of ECSU will be able to use different tools provided by multiple disciplines to understand cities and the role they play in the development and functioning of civilization. Urban Planners, Engineers, Urban Land Development and Management, Geographers, Architects, Urban Infrastructure and Transport Management, Housing and Real Estate Property Management Professionals and Environmental Management Scientists all study their respective cities and towns from their specific theoretical and

philosophical perspectives. The Urban Development and Engineering Programs at ECSU are based on the recognition of this multi-disciplinary, and it aims to provide students with a multitude of lenses through which to observe, interpret and understand urban life.

The Programs in CUDE are suited for those students who wish to study cities using several disciplinary approaches. It is also of interest to those students who wish to be involved in urban issues in Ethiopia and African Regions. The Programs offer different analytical tools as part of their experiential learning.

The program description and admission requirements of the programs are described below.

# 1.1. Urban Planning and Development

Due to the accelerating rate of urbanization, urban planning becomes essential in guiding, directing and managing urban spatial development trends. The complexities in the urban fabric have resulted in the need to train professional urban planners. The need for urban planning professionals in Ethiopia is growing rapidly with the increased awareness on the part of regional governments and city administrations. The general objective of this Master's Program in Urban Planning and Development is hence to produce highly qualified planning experts specializing in urban planning and development. The Program aims at producing graduates highly equipped with theories and practices in urban planning and development at different urban levels. The program is set to be completed on a full time basis within a period of two years comprising of four semesters.

#### **Admission Requirements:-** The candidates for this program should have

 A bachelor's degree from recognized Higher Educational Institutions in Urban Planning, Urban Planning and Design, Urban Engineering, Urban Transport Planning, Urban and Civil Engineering, architecture, Architecture and Urban Planning, Civil Engineering, Surveying, Architectural Engineering, Surveying Engineering, Urban and Regional Planning, Architectural Design and Drafting Technology, GIS and Remote Surveying.

## 1.2. Environment and Climate Change Management

The Master of Environment and Climate Change Management Program provides an in-depth look at environmental management, imparting the knowledge that is needed for graduates to work in the environmental and climate change management area. The programme is designed to produce qualified civil servants in Urban Environmental and Climate Change Management to support the efforts of the regional and municipal governments in undertaking environmentally friendly urban planning and development programs. It aims at producing graduates who are equipped with theories, tools, skills and perspectives for enhancing best practices in urban environmental planning and climate change management. The program is set to be completed (on a full time basis) within a period of two years.

#### Admission Requirements:-The candidates for this program should have

- Bachelor degree from recognized Higher Educational Institutions in Environmental Management, Environmental Protection, Environmental Studies, Environmental Science, Natural Resources Management, Climatology, Climate Change and Development, , Range Land Management, Land Resource Management, Forestry, Water Resources, Geology, Environmental Health, Botany, Biodiversity, Environmental Engineering, Sanitary Engineering, Landscape Design and Planning, Waste Management, Meteorology and Atmospheric Science, Water Resource and Irrigation Management, Soil Resource and Watershed Management, Plant Science and Protection.

  - Must serve at least two years after graduation in the public service (for Regular& Summer)

# 1.3. Transport Planning and Management

Transport is widely recognized as fundamental to economic growth. However, like many Sub-Saharan African countries, Ethiopia is facing transport challenges. To overcome these and other development issues, Transport Planning and Management is crucial. Therefore, the Program endeavours to fill this niche by keeping students with relevant Transport Planning and Management skills, such as planning and managing the transportation sector. The core modules of the Program includes Transportation System and Development, Transport Economics and Governance; Fundamentals of Traffic Engineering and Road Safety Management; Transport Logistics and Operation Management; Transport Planning and Modelling; Research Methods and Techniques I and II, GIS I and II, Transport Studio I and II in the two years. In the second year, the batch will be divided in to two: the specialization with thesis and without thesis. The program is set to be completed on a full time basis within a period of two years comprising of four semesters.

#### 1.4. Urban Infrastructure Provision and Management

Ethiopia is experiencing high rate of urbanization, which puts pressure on the existing urban infrastructure and services and further calls for more infrastructure and service expansion and investment to meet the growing demand. This calls upon the training and skill development of the human resource in field of urban infrastructure.

The master program is of two years, structured in four semesters. The Program module includes Urbanization and Urban Development Management, Research Methods and Techniques, Infrastructure Studios; GIS, Urban Infrastructure Planning, Management and Urban Infrastructure Financing,

Municipal Infrastructure Service Management, Urban Project Management, Urban Road and Transport Infrastructure Management, and Capital Investment Plan and Asset Management.

#### 1.5. Urban Management

Although Ethiopia is one of the least urbanized countries, it is experiencing unprecedented rate of urbanization of about 5%. Rapid urbanization comes with various challenges which state and local planning authorities must deal with. Rapid urbanization exerts pressures on the goods and services provided by state and local planning authorities. The challenges which accompany rapid urbanization include: environmental degradation, spiralling urban poverty, food insecurity, crime, HIV/AIDS, unemployment, slums and squatter settlements, among others. The combination of advanced training methodologies and delivery by a select team of experienced academicians and professionals will facilitate the link between theory and practice.

- Should not be older than 48 years of age;
- Successfully pass ECSU entrance examination (above the cutoff point set by the University)

#### 1.6. Urban Land Development and Management

The Government of Ethiopia is undertaking radical reforms in governance and development including Urban Land Development and Management. The overarching goal is to make land management and administration more effective, efficient and harmonized in contributing towards the implementation of public policy goals. The Program will equip students with analytical and practical skills in urban land and sustainable development, land management and administration, research practice.

#### **Admission Requirements: -** The candidates for this program should have

- Bachelor Degree from a recognized university in Land Administration, Urban and Regional Planning, Urban Planning, Urban Management, Applied Geography, Architecture, Urban Engineering, Economics, LIS, GIS, Infrastructure and Land administration, Urban Land Management and Information System, Infrastructure, Transport, Real Property and Asset Management.
- Recommendation letter from employer organization (Only for Regular & Summer) (Form 002).
- Should not be older than 48 years of age;
- Successfully pass ECSU entrance examination (above the cutoff point set by the University)
- Must serve at least two years after graduation in the public service (for Regular& Summer)
- Who can present official transcript before the registration date when selected.

# 1.7. Housing Development and Management

The program is designed to upgrade the capacity of public and private sector professionals and for those wishing to specialize in the housing area. It analyses the contexts of housing, both nationally and globally in terms of political, economic and social developments; it provides a critical evaluation of international housing systems; provides a deeper level of knowledge and understanding of some selected urban and housing issues such as housing finance, property development and urban management models. It also equips students with useful techniques and skills in the analysis of urban and housing issues; and enables students to specialize in some aspects of housing. The program is set to be completed on a full time basis within a period of two years comprising of four semesters.

# 1.8. Urban Property Valuation & Asset Management

This program is designed to equip graduates with knowledge and skills applicable to a variety of career paths such as investment, finance, asset management and research. The Program addresses a range of topics including finance and taxation, corporate portfolio management, risk identification and management, feasibility analysis, land law, property valuation and market analysis Special emphasis is given to core modules such as: Land Administration Management and Land Law, Real Property Registration & LIS, Land and Real Estate Construction Economics, Real Estate Investment Financing and Business Administration, Municipal Infrastructure and Asset Management, Geospatial Techniques for Urban Property Valuation and Asset Management, Real Property Valuation and Taxation. The program is set to be completed on a full time basis within a period of two years comprising of four semesters.

#### 2. COLLEGE OF FINANCE, MANAGEMENT AND DEVELOPMENT (CFMD)

Recently, the University undertook a substantial structural change that resulted in the establishment of three Colleges of which College of Finance, Management and Development is the one. The College is created by merging the former Institute of Public Management and Development Studies and the former Institute of Tax and Customs Administration. The College has six academic departments consisting of 14 Programs at Undergraduate, Masters and PhD levels. The Academic Departments are: Department of Public and Social Security Management, Department of Development Economics and Management, Department of Public Financial Management and Accounting, Department of Public Procurement and Asset Management, Department of Tax and Customs Administration, and Department of Mathematics and Statistics.

# **2.1. Public Management (PM)**

Effective implementation of the Ethiopia's Government development plan requires committed and competent public managers. It has been observed that over the years the government organizations in Ethiopia have found it difficult to fill certain vacant positions particularly at the higher organizational levels. It is believed that presently there are a large proportion of civil and public servants in Ethiopia who do not possess the requisite qualifications to fill such positions or vacancies. As a result the Government and stakeholders have identified the development of a Master's Program in Public Management as one of the several intervention strategies to be used in closing this capacity gap.

The main objective of the program is to produce public managers capable of attuning to implement the government development policies in the interest of the public at large. It aims at equipping the students with the basic concepts, theories and tools for analytical thinking, sound judgment, innovation, leadership and other managerial skills required to serve the public.

# 2.2. Social Protection Management

The Master's Degree in Social Protection Management is designed to support the managerial and policy development capabilities of people looking at careers within the evolving social protection system in Ethiopia. It seeks to provide a comprehensive range of courses for managers in social protection. The Program incorporates both public and private financing and delivery mechanisms for a range of social risks, including: old age, death and disability, sickness protection, health protection, unemployment, and the protection of vulnerable families.

# 2.3. Development Economics (DE)

The main purpose of this Program is to strengthen Ethiopian human resources in specialized theoretical and applied development policy areas. The Program focuses on poverty and income distribution, the roles of technical change and inter-sectoral linkages in economic development and the significance of the state in the process of policy formulation for development. It aims at providing students with the theoretical knowledge, policy awareness, problem solving research techniques and skills to tackle many of the challenges relating to economic development of the country. This will enable them to actively participate in decision-making on policies designed to promote sustainable development in the country, improving student's insights and ability to recognize and resolve economic policy issues in a methodologically sound and effective manner, and strengthening student's capacity for evaluating

policy options of the country against the background of the contemporary development theories and practices.

# 2.4. Public Financial Management (PFM)

The Public Financial Managements is designed with a view of producing civil servants who are cost conscious, ethical, and capable of generating funds and utilizing it optimally. The Program aims at producing skilled personnel that can participate in policy decisions related to Public Sector Financial Management and the collection and utilization of the government financial resources. The Program enables students to gain understanding of how the government matches the needs of the society with scarce economic resources. Students will also develop a skill in formulating the budget, follow up its implementation, and exercise adequate budgetary control.

#### 2.5. Accounting and Finance

The increasing complexity of the current world business environment and continued development of accounting and finance practices have increased the need for graduate level in Accounting and Finance Program. Moreover, the Ethiopian public sector has been under continuous reforms which demands qualified manpower to sustain the growth and development of the country. Accounting and Finance is one of the academic fields that require capacity building of the public and private sectors of the country to fill the gap of qualified personnel in labor market. Accounting and Finance is designed to respond to the existing shortage of trained human power in the finance sector.

- Bachelor's Degree from recognized Higher Educational Institutions in Accounting, Finance, Accounting and Finance, Business Economics, Business Management, Economics, Economics and Management, Banking, Cooperative, Finance and Developmental Economics, Banking and Finance, Business Administration, Accounting and Audit, International Trade and Investment management, Management and Information System (MIS).

- Should not be older than 48 years of age
- Successfully pass ECSU entrance examination (above the cutoff point set by the University)

#### 2.6. Customs Administration (CA)

Customs Administrations in many countries usually suffer from two serious diseases – corruption and fraud. Realizing this, the Government of Ethiopia has decided to revamp the system of customs in the country with a view of making the customs administration free from corruption and fraud, and making it transparent and revenue- generating. Owing to reforms made in the customs administration, the revenue collection has increased by multimillion, simultaneously with a substantial reduction in corruption and fraud. An obstacle that confronts all the efforts of the customs administration is the lack of trained personnel in the area of Customs Administration. Hence, it has become a necessary step to build the capacity of the civil servants with the required knowledge, skills and attitudes at Master Degree Program so as to respond to the existing shortage of trained human power in the area of Customs Administration.

# 2.7. Tax Administration (TXA)

Central to the revenue system in any country is taxation which provides the country with the lion's share of its revenue. Mobilizing adequate resources from taxation, the key source of revenue for the

government, and making it available for implementing developmental programs in the country requires an impeccable revenue management system. The major problems that make the tax system of a country crippled are corruption, tax evasion, and lack of transparency. Lack of trained manpower in the area of taxation and the absence of a well-designed tax management system exacerbate the problem and create serious damages in the economic and the social systems of the country.

Though the Government of Ethiopia has gone a long way in reforming the tax system of the country, it hasn't been able to fully reap the fruits of the reform, mainly due to lack of trained personnel in the area of tax administration. Absence of the study program in many of the higher learning institutions contributed to the low conceptual knowledge, skills and experience in the area. It was with this dire need and emphasis stipulated in the aforesaid document that the Ethiopian Civil Service University played a pioneering role to launch the Program.

Policy actors at all levels need to be versed with the basics of public policy science in order that policy implementation would help ensure in achieving set goals and objectives. Hence, the overall objective of this master's program is to enhance students' policy knowledge, skills, policy partnership and ownership attitudes in order that effective policy outcomes and impacts can be realized for the targets they are designed.

Such procedures

help policy analysts to adhere to their professional integrity, while policymakers have to make final political decisions which are of a multifaceted nature and beyond the analysis forwarded to them.

On the other hand, knowledge and skills of policy analysis is critically important for public managers and experts at all levels of government. Hence, owing to the paramount role of policy analysis in the policy making process and the obvious trained experts' gap in the area in Ethiopia and thus, ECSU, has launched a new master program in Policy Analysis.

# 3.8. Comparative Public Law & Good Governance (CPLGG)

The formal adoption of federalism by the FDRE constitution, the implementation of new economic policy, the enhancement of roles and responsibilities of the public service institutions, and the consequent need for highly qualified legal experts that can provide theoretical orientation and practical solutions to the new system have been major reasons for launching the program. # 3.10. Federalism and Local Government Studies (FLGS)

Ever since the introduction of the federal system in Ethiopia, there has been an increased demand for professionals qualified in the area of Federalism at different levels. The due implementation of federalism in Ethiopia has been seriously hampered by a shortage of competent, skilled professionals to ensure the operation of federal institutions in the legislative, executive and judicial bodies. The overall objective of the program is to contribute to the discourse on federalism in general and to strengthen the federal system of Ethiopia in particular by producing competent professionals at the federal, regional and local levels. The program is primarily designed for practitioners of federalism at federal, regional and local levels. It is, however, also open for those interested in pursuing high - level academic study on several aspects of federalism with a view to serving as policy analysts, advisors and consultants.
